ASSESSMENT PAYMENTS

Just a reminder that 2018 annual assessment notices have been sent to all members of the Association at the last address of record provided by members. If you have moved, or if you do not receive an invoice by January 10th, please contact Berkeley Realty Property Management (757-229-6810 ext. 212 Talaya Spratley, accounting) for a copy. Please remember that the annual assessment for 2018 will be \$210.00 for each lot.

You can mail payments, arrange for direct payments to be made through your bank, or go online to Smartstreet and make a credit card payment or set up automatic payments. Each of these options has some limitations that you should take into consideration. Mailed payments can get lost or delayed, which can affect your payment record and possibly result in late fees or interest – remember payments cannot be credited until they are received, not by postmarked date. Automatic payment arrangements through your individual bank, or even the Association's bank, Smartstreet, are usually set up for a finite period, and the arrangements will need to be renewed periodically. Credit card payments come with a fee cost.

However there is an option that is available to members of PCSA that has none of these limitations. This option is called <u>ACH Debit</u>, and is available through Berkeley Realty Property Management. You as the member of PCSA are the only one who can authorize this service, and you retain the right to cancel this service at any time. 

Woodworkers Wanted!

The bulletin boards at entrances to Powhatan Secondary are in sad shape. Of the three, the one at the News Road entrance, is the one in the best condition-and still needs work. We need new ones! We also need a fourth board for the Colonies entrance. Replacing them with commercial boards has been checked, and found to be very pricey.

These are fundamentally very simple structures. The legs need to be treated wood, otherwise they only need to be sturdy, stable, and have a hinged door with a clear plastic window that is easy to use.

If one or more woodworkers would like a fairly simple project, building new boards would be a good winter project. We can agree on a design; materials will be reimbursed by PCSA. This could also make a good Eagle Scout project!

We are recycling. What can go wrong?

We have the best intentions when we recycle. We put our recycling items in our rolling recycling carts and put the carts out at the street on the designated days for automated collection. Recycling is a positive way we participate in doing our part. We are recycling. What can go wrong, we ask?

I learned what can go wrong as I listened to an interview with Michael Taylor, director of recycling operations for a waste management plant in Elkridge, Md. Taylor asserts, "Don't recycle plastic bags, even if they're full of newspaper. They gum up the whole processing system." Every few hours Taylor has to shut down the machines to remove all the plastic.

"Take your plastic bags back to the grocery store," he says. (full story at https://www.npr.org/2015/07/17/421211023/reduce-reuse-remove-the-cellophane-recycling-demystified)

Hearing this prompted me to want a local perspective, so I reached out to Tracy Hofmeyer, recycling coordinator for Virginia Peninsulas Public Service Authority (VPPSA). VPPSA is the regional governmental organization that provides solid waste management services to us here in James City County and to nine other cities and counties in southeast Virginia.

Hofmeyer's response echoes what I heard from Taylor in the interview. ANY type of plastic film causes problems at the recycling processing plant, she says. This plastic film includes:

- * Trash bags
- Plastic grocery store bags
- Produce bags
- Plastic film wrapping from bottled drink flats
- * Plastic wrapping from bulk packs of paper towels, etc.

Hofmeyer explains, "The materials collected at the curb are taken to a processing plant in Chester, Virginia. There the materials are loaded on a conveyor belt where they begin to go through the mechanical sorting process.

Plastic bags become tangled in the various pieces of sorting equipment, to the point that the machines are forced to shut down in order to clear the bags. For a plant that can sort up to 30 tons an hour, shutting down for 45 minutes to clear out plastic bags tangled in the moving parts has a significant effect on productivity!"

Because we want our participation in recycling to make a positive difference, awareness of the problematic impact of plastic film to the recycling process can help us. Take plastic bag and plastic film for proper recycling at most any grocery store in our area. Help spread the word!

SIDEBAR:

Automated recycling collection

Automated recycling collection is a method in which the driver operates a collection arm from inside the vehicle; there is no need for the driver to get out of the vehicle. This method provides the most efficient collection from the largest number of carts; by offering this method, the contractor has a finite volume of material to be collected. When a contractor bids automated collection there are fewer potential cost variables, reducing the unit collection costs.

To best support our automated recycling collection:

- * Place recycling cart where the arms of the truck can grab it. If a cart is placed too close to a parked car or mailbox, or under a tree with low-hanging branches, the driver may not be able to service the cart.
- * Break down recyclables and flatten boxes to best utilize space in the recycling cart. Avoid placing recyclable materials next to the recycling cart; the driver cannot hand load materials into the top of the collection truck.

SAFETY REMINDER

The James City County Police would like to remind all residents of the importance of taking a few steps to help improve safety and security. Please don't leave valuables in vehicles. Make sure that your vehicles are always locked, even in your driveway. Make sure your mailbox light, and your porch lighting is working property with white bulbs.

The JCC Crime Prevention unit also provides other services to residents of the county – home security evaluations, home checks while you are away, seminars on safety and avoiding scams, to name a few. Reporting Concerns to VDOT (The Virginia Department of Transportation)

The Virginia Department of Transportation (VDOT) is responsible for the care and upkeep of the roads (except for Cluster Way) and road drainage inlets in our community. We are asked to report problems by accessing their website. The local office has been very responsive, though it may take time to actually make the repairs. You are issued a tracking number and can see where the repair is in the system.

Architectural Review Committee (ARC)
Notes

This new segment in the Powhatan Signal is intended to inform homeowners and to highlight recurring issues.

The Architectural Guidelines were created to assist Powhatan Secondary homeowners in adhering to the Covenants and Restrictions regarding plans submitted for modifications, alterations or additions made to any new or existing structures and any significant alteration or improvement to any lot undertaken in Powhatan Secondary. These Guidelines have been incor-

porated into Powhatan Community Services Association's (PCSA) Book of Resolutions and serve as the primary guide of the Architectural Review Committee (ARC).

It is the responsibility of all homeowners to request and obtain ARC approval for projects.

If you did not receive a copy of the Architectural Guidelines at settlement, or if you have misplaced your copy, you may download a copy from the PCSA website - http://powhatansecondary.org/index.php#. Under the "Documents" Tab, select Governance, and you will find the Guidelines, Attachments (with examples of acceptable fences, mailbox posts and lights, and storage sheds), and the ARC Application form.

The following two items are provided this month to highlight issues the ARC has seen on a regular basis:

Mailbox Exterior Post Lights. Each home having its own mailbox is required to have an operating exterior post light of a design and at a location designated by the ARC (Refer to Architectural Guidelines dated September 2016). Post lights are to operate dusk to dawn, using a clear white or frosted white incandescent 60 watt bulb or equivalent CFL/LED bulb. Post lights are controlled by photo electric cells. Replacement photocells can be purchased at local hardware stores for \$10 - \$15. On a case-by-case basis, the ARC will consider an acceptable low voltage replacement for the original post light. However, solar lights are not acceptable.

Trees. No live trees with a diameter in excess of five (5) inches, no flowering trees in excess of three (3) inches, no live vegetation on slopes of greater than 20% gradient, may be removed without the consent of the ARC. Removal of any tree or trees deemed a danger to any home will be approved if requested.

James City County residents may drop off leaves free of charge Jan. 2-21 at the Jolly Pond Convenience Center, 1204 Jolly Pond Road, daily from 7 a.m.- 5 p.m, in <u>clear</u> bags no larger than lawn or leaf-size (40 gallons or less).

Burning of leaves is not permitted in James City County.
