- 2. Deck repairs at 3756 Lake Powhatan
  - a. Board members inspected deck on May 30<sup>th</sup> and agreed with homeowner that deck condition was a safety risk and the condition of the deck was not due to normal wear and tear or misuse.
  - b. Property Manager contacted two deck companies for cost estimates of the repairs needed.
  - c. Board voted to pay for the deck repairs (\$3000.00).
  - d. Homeowner will contact Property Manager once she makes a decision as to whether she wants to make adjustments/modifications (at her own expense) to the deck.
- 3. Decks repairs at 3720 Lake Powhatan
  - a. Board members inspected deck on May 30<sup>th</sup>.
  - b. This deck had been enlarged and altered by the previous owner.
  - c. The Board agreed that because of the alterations the HOA is no longer responsible for the repairs on this deck.
